#### **BOARD RETREAT**

The Board of Trustees had a retreat for their special meeting, which included the following updates:

## Capital Projects

Laura Price, Director of Facilities, provided an update on Capital Projects:

- Lacey 3 Remodel/Completion Update:
  - A preliminary assessment and cost projection to complete Lacey 3 was completed in May 2016 by KMB Architects.
  - o Building 3 is approximately 20,430 sf.
  - Assumes 4-6 general classrooms or computer labs, breakout rooms, conference room, offices, and service areas.
  - Preliminary total estimate project Cost: \$3,200,000
  - o Occupancy: Fall 2018
- Health and Wellness Center Feasibility Study Update:
  - The Associated Student Body (ASB) commissioned a feasibility study to explore options for a Health and Wellness Center at the Olympia campus.
  - Option 1: Renovation of Building 33 and Improvements to Building 31; and Option 2: New Facility sited at the current location of Buildings 31 and 33. The Associated Student Body leadership is working with Executive Team and the Board to package the information for students, then students will take a vote.

 Proposed Mixed-Use Student Housing idea from a private developer was discussed. The college remains interested in the proposal and will help market it to students, but is not interested in entering into any master lease or financial commitment.

## Operational Plan

Vice President for Instruction Dr. Michelle Andreas and Vice President for Student Services Dr. Dave Pelkey, provided an update on the 2016-2017 Operational Plan by discussing the strategies and expected outcomes for each of the Core Themes: Expand Student Retention and Completion; Inspire Teaching and Learning Excellence; Advance Equity and Embrace Diversity; Champion Innovation; and Build Community.
