

NON-RESIDENT WAIVER REQUEST

for Active Duty Military personnel or dependents who live In Washington

Enrollment Services

To be effective for the current quarter, the deadline to submit ALL required documentation is the 30th calendar day of the quarter. If complete documentation is received after the 30th calendar day of the current quarter, approved residency changes will not take effect until the next quarter.

ELIGIBILITY: A student who is on active military duty stationed in Washington, their spouse and dependents; Washington National Guard members and their spouse and dependents (if their residence is Washington).

CONDITIONS: If approved, students will be classified as a Washington State resident for tuition purposes. However, they will not be eligible to receive financial aid benefits that are available for students who satisfy the statutory residency requirements. **PROCEDURES:** Complete the application section below and return this form to the Enrollment Services office with the following:

Military ID card and the orders that show the date of you or your sponsor's assignment to Washington State.

NOTE: RECENTLY DISCHARGED VETERANS WHO SUBMIT DD-214 (MEMBER 4 PAGE) AND CERTIFICATE OF ELIGIBLITY TO ENROLLMENT SERVICES OR THE SPSCC VETERAN'S OFFICE WILL ALSO BE CONSIDERED FOR THE APPROPRIATE NON-RESIDENT WAIVER.
