- ACT Legislative Action Committee (LAC): Steven Drew; Jeff Davis
 - o There was no meeting and no report.

- Foundation Board: Judy Hartmann; Leonor Fuller
 - Trustee Fuller reported the following:
 - Thanks to Trustee Judy Hartmann and her husband Mike for hosting the Foundation Board members and Trustees at the Board Summer Reunion in July.
 - If the Board of Trustees approves Policy 116 at this meeting, she plans to present that information at both Foundation Executive Board meeting and the Foundation Board of Directors meeting.
 - Similar to the Board of Trustees' review/update of its policies in 2018-19, the Foundation's Governance Committee led by Cindy Hough and Ted Schultz, is also reviewing and revising the Foundation policies.
 - She noted the College Foundation's Annual Report which shows an increase in revenue.
 - Congratulations to Shannon Glenn for her good work with two events: SPSCC Alumni Night at Tacoma Rainiers in August and the Clink and Connect Alumni Mixer in September.
 - The Experience is on October 5, 2019, and they expect a sold-out event.

REPORT FROM THE COLLEGE PRESIDENT

- Dr. Stokes reported the following:
 - o No Reports from: Student Senate, Faculty Union, and Faculty Senate.
 - o Enrollment Report Update: Enrollment around the state is down. We have a 3% increase in overall enrollment. State enrollment is flat compared to last year's; Running Start enrollment continues to grow and is up 4%; and International enrollment is up 2%.
 - Chair Mah shared that at one of the ACT board meetings, some trustees that attended a national conference are warning others to not expect the bump in enrollment if there is a recession because of the changing age demographic. Historically, when the economy is down, enrollment is up.
 - o Vicky Chungtuyco, Foundation Database Coordinator, received the 2019

Exemplary Staff Award from the Staff Training Association for Technical and Community Colleges for Region A, "to recognize commitment and excellence in job performance and dedication to the professional development of the classified staff on our campus."

POLICY

Board Policy

The Board received copies in July of draft *Policy 116: College Foundation Policy*, which was presented for Board approval. The Board discussed the agreement between the College and the College Foundation. A few amendments were included at our Counsel's suggestion—to review the terms of the agreement at least every three years and to add the College President's role as a member of the Foundation Board of Directors.

It was moved by Trustee Hartmann, seconded by Trustee Davis **THAT THE RECOMMENDED CHANGES TO POLICY 116 BE ADOPTED BY THE BOARD AS PRESENTED. THE MOTION CARRIES.**

STUDY SESSION

Probationary Review Process

Vice President for Instruction Dr. Michelle Andreas discussed the faculty tenure process with the Board:

- RCW 28B.50.850-869 governs the tenure process
- The big picture includes the College's mission, vision and values, and Strategic Plan core themes
- Trustees communicate their priorities. Based on core themes, trustees annually
 discuss probationer concerns with the president and the vice president for
 instruction; annually review probationary reports from committees; and meet with
 probationary candidates prior to granting tenure.
- What Happens Behind the Scenes: Probationary Review Committee (PRC)
 orientation that addresses trustees' priorities; Union negotiation on evaluation
 forms and processes; and discussion and necessary action related to tenure
 problems.
- Evaluation forms and process: Instructor evaluation by students; Class observation by peers; Administrative evaluation of faculty; Faculty selfevaluation; Faculty development guide.

- The PRC reports include: Probationer background; PRC membership; Committee's recommendation; Summary of all student evaluations to date; Summary of peer, administrative, and self-evaluations to date; Summary of strengths; Summary of areas for improvement; Action taken by probationer to address areas for improvement; Probationer's plan for future professional development.
- Discussion of probationary report and process
 - The report: What aspects of the report work well? What changes or modifications might better inform the board?
 - The process: What aspects of the process work well? What aspects of the process could better inform the board?

It was decided to add a Board probationary review discussion the month of April, after each year's March probationary review process.

COMMENTS FROM INDIVIDUAL MEMBERS OF THE BOARD OF TRUSTEES

• Trustee Fuller commented that it has been an honor and privilege to be on this Board of Trustees (17 years), and one of the most fulfilling in her life. She said, "I've been very deliberate about my institutional history in the hopes that this Board has benefitted from it, and I've been cognizant of trying to make sure that I bring that to the table without sacrificing the forward looking that we all do so well together." As a symbol of her appreciation, she presented each with a photograph she took of the old Brew House and told them that it is "looking back on the old Brew House and the future Brew House that you will be building and opening." She also spoke about the growth that the college has gone through.
