- ACT Legislative Action Committee (LAC): Steven Drew, Jeff Davis
 - Trustee Drew reported the following:
 - The LAC participants broke out into regional groups for discussion, and one of their top three recurring issues was housing challenges.
 - There was also discussion on how to be effective advocates and how to connect with legislators, and enlisting students in working with legislators.
- · Board Finance Committee: Jeff Davis, Steven Drew
 - Trustee Davis reported that the Board Finance Committee met on December 2 to review all the financial reports to be discussed later under Budget and Finance. He noted that the numbers look great and that there are no concerns.
- Foundation Board: Judy Hartmann
 - Trustee Hartmann reported the following:
 - Foundation will be moving to the Dr. Angela Bowen Center starting December 10-12, 2019.
 - They are getting ready to ramp up for the spring campaign.
 - Party with a Purpose hosted by Tumwater Administrator John Doan and David Marks, raised over \$13,500 for the LGBTQ students.

REPORT FROM THE COLLEGE PRESIDENT

- Student Senate Report: AJ Edwards, ASB President, reported some activities:
 - They registered 81 new voters during Voter Registration; they are working toward (Open Educational Resources) OER advancement; they have 5 additional clubs; they collected 159 toys for the Toy Drive.

- Internships, work-study opportunities and service learning credits are available through the garden-raised bounty project.
- The Food Pantry has had over 525 visits this fall, which is over 50% increase from the previous fall. They are working to expand the Pantry.
- Over 1,000 students voted for the Dog Shark in their mascot survey.
- Faculty Senate Report: Melanie Shelton, Baking & Pastry Arts Professor and Faculty Senate VP/Prof. Tech. Representative reported:
 - o They received approval to create a graduation video for June 2020.
 - They are onboarding new faculty as an informal way of creating community and making connections. They are also supporting faculty as they shift grading to Canvas.
- Faculty Union Report: Dr. CJ Dosch, English Professor & Faculty Union President reported:
 - It is "steady and solid for the Union" at this time, and elections are underway for Union officers.
- Dr. Stokes reported the following:
 - Health inspection for the Percival Place at Ben Moore's passed.
 - The 2021 Aspen Prize application was submitted on December 4. Finalists will be announced in May 2020. Thanks to Dr. Dave Pelkey and Jennifer Tuia for coordinating and drafting our application.
 - Yelm High School+ Program: 37 individuals earned their high school diplomas through the High School+ Program during the winter, spring, and summer quarters of 2019. The HS+ Program is a collaboration among SPSCC, Yelm Community Schools, Yelm Timberland Library, and the South Sound YMCA.

WHEREAS, Leonor Fuller is respected and honored by her peers as a unique, enthusiastic and loyal champion of SPSCC, its faculty and staff, and its students;

BUILDINGS AND GROUNDS

2021-23 Capital Request and Campus Master Plan

Marty Mattes, Director of Facilities, reviewed the changes from the 2015 to the 2019 Campus Master Plan. He noted that the updates address new and revised strategic plan, building programming needs, facility conditions, goals and implementation plan. The updated Master Plan would have to be approved and submitted with the Capital Project Request to the SBCTC December 18, 2019.

Ross Whitehead, Principal with SSW Architects, provided information on the 2021-23 Major Capital Project Request. He reviewed the problems with outdated Buildings 13, 26, 29, 30, and 32 across campus that affect the efficiency and effectiveness of teaching and learning. He discussed proposed solutions and possible project requests and scoring outcomes that could potentially place the college in the que for state allocated capital funding.

After much discussion, the Board's general guidance included moving forward with the larger project for what the college needs and what would work for the future, while recognizing the risk of reducing the score but still scoring above 70.

It was moved by Trustee Davis and seconded by Trustee Drew THAT THE BOARD OF TRUSTEES APPROVE THE 2015 CAMPUS MASTER PLAN UPDATES TO 2019 AND AUTHORIZE THE SUBMITTAL OF THE 2021-23 CAPITAL BIENNIUM PROJECT REQUEST REPORT (PRR) TO THE STATE BOARD FOR COMMUNITY AND TECHNICAL COLLEGES. THE MOTION CARRIES.

BUDGET AND FINANCE

Quarterly Financial Report

Vice President for Administrative Services Al Brown reported on the 2019-20 Operating Budget through September 30, 2019. He noted three primary areas where we could go askew on the budget:

- 1. If the state would cut our funding—but we do not foresee state cutting allocations this year
- 2. If enrollment projections were off—but we were very conservative in putting the budget together, projecting state to be down and Running Start enrollment to be flat, and they are both actually up
- 3. If large, unexpected expenses occur—but there has not been any unexpected expenses and we do have a contingency line in the event state would cut us

(FY20) YTD – (Actual) Variance:

- Total Operating Revenues \$1,098,363
- Total Operating Expenses \$ 489,289
- Operating Surplus (Deficit) \$ 609,075

He said the budget looks good as reflected in the year-to-date variance. As long as enrollment continues to be strong for the other two quarters, we will be in good shape.

Director of Budgeting & Fiscal Services Rochele Johnson briefly reviewed the following reports: Non-Operating Accounts Statement of Revenue & Expense Year-to-Date through September 30, 2019; and Capital Budget Status as of September 30, 2019.
