- A. Review of accident/injuries reported Three (3) incidents were reported.
 - 1. Culinary student was using the meat slicer and reached below the guard to keep the meat from sliding. The tip of their finger on the right hand was sliced off (recommended culinary re-train and provide supervision).
 - 2. Employee was cleaning GTAW filler rods in the Welding Department. One of the rods pierced their finger and palm causing a superficial puncture wound.
 - 3. Employee was coiling laptop chargers and cords. One of the cables was pulled too fast and struck the employee's left eye. (pending supervisor report).
