#### I. Reports

A. Review of Safety and Health Inspections:

None were conducted during this reporting period.

#### II. Accident Investigation:

- A. Review of accident/injuries reported Five (5) incidents were reported.
  - 1. Dental student was processing instruments, when one slipped off the counter and made impact with their left leg.
  - 2. Dental student was picking up a bundle of instruments and got poked in the right index finger.
  - 3. Welding student was carbon arc gouging when a piece of molten metal burnt through their pants and front of their boot. First aid treatment was administered.
  - 4. Employee was driving near the bus loop when the gate of the vehicle swung open and made impact with the mirror of the city bus. No injury occurred.
  - 5. Employee was pulling a club car into building 15 when the door struck an object and broke the glass mirror. No injury occurred.

#### III. L&I Report

A. For the month of December 2018 there were four (4) claims totaling Two Thousand Five Hundred Sixty-Four Dollars and One Cent (\$2,564.01). The College has not received claim information for the month of January 2019.

Rates for claims are down this year. A large claim just came off. This is the lowest it's been in a long time.
