II. Accident Investigation:

- A. Review of accident/injuries reported There was four (4) incidents reported.
 - Employee was stacking chairs in the Black Box Theatre in preparation of cleaning the floors.
 While lifting the chairs, employee felt a sharp pain in the neck, as well as in the elbow and hand.
 - 2. Employee was assisting with loading pallets of surplus computers. The pallets fell from the lift truck and one of the computers struck the employee. The impact caused a cut to the employee's lip and finger.
 - 3. Two employees were assisting with tear down of tables from kick-off week. One employee ran over another employee's foot with a loaded table rack. The impact caused swelling and discoloration to the employee's toe.
 - 4. Employee was loading a desk onto the tailgate of a truck without assistance. The lifting caused a strain to the Employee's left side of the groin muscle.

A. For the month of August 2018 there were four (4) claims totaling Two Thousand Four Hundred Fifteen Dollars and Seventy-Two Cents (\$2,415.72). The College has not received claim information for the month of September 2018.
