They did great work on the language issues, and we are implementing their recommendations.

- ACT Legislative Action Committee (LAC): Doug Mah, Jeff Davis
  - o Trustee Mah reported:
    - At the ACT Spring Conference, the State Board will be presenting on the highlights from this year's legislative session.
    - He serves on the ACCT Public Policy and Advocacy Committee. All of the discussion/update is all about money: debt ceiling negotiations; House & Senate reviewing individual projects; \$1.5M request for B.S. in Cybersecurity and Computer Science made Sen. Cantwell's short list; Higher Education Emergency Relief Fund (HEERF) deadline is coming up end of June.
- Board Finance Committee: Steven Drew
  - Trustee Drew reported that the Board Finance Committee met to review the financial reports, which indicate the financials are good and strong. He deferred the details to Dr. Tysha Tolefree.
- Foundation Board: Judy Hartmann
  - Trustee Hartmann reported:
    - No report today. She deferred the annual report to Annie Iriye, President of the Foundation Board of Directors.

#### REPORT FROM THE COLLEGE PRESIDENT

- Dr. Stokes reported:
  - No reports from the ASB President, Faculty Union President, and Faculty Senate Coordinator.
  - ASB senator for legislative affairs Sophia Bowton-Meade was selected to the 2023 ALL IN Student Voting Honor Roll. She was recognized by ALL IN for student voting and legislative advocacy work.
  - SPSCC's Healthcare Education program has been chosen as a 2023 Healthcare Champion Future of Healthcare Award recipient. This award is provided annually to individuals and groups in Thurston and Mason counties whose contributions to healthcare are impactful and are selected by a committee of healthcare

leaders in the community. It is sponsored by the local medical society and the Thurston County Chamber of Commerce. The recognition event will be held June 27 at the Olympia Country and Golf Club at 5:00 p.m.

- o 10th Day enrollment update: Enrollment was up 5% over last year.
- They will seek Board approval in June for a 10-year lease of the former horticulture building with Tumwater Water Quality Department.
- They are in lease negotiations to continue partnership at the CBD Center
- The college will be starting Men's & Women's Golf Program in partnership with Tumwater Valley Golf Course.
- CODA, our accreditor for Dental Assisting, only had one curriculum recommendation for our Dental Assisting Program, which is one of the best programs in the country. Congratulations!
- He noted the President's Outreach/Professional Development/Advocacy List that was provided to the trustees.

#### **POLICY**

Code of Student Rights & Responsibilities

Dr. Dave Pelkey reported that notification of the proposed rules were published in *The Sounds* college newspaper for public comments. There were no comments received in response to the proposed rules and there were no comments at the public meeting. He noted the new WACs reflect revisions to the Code of Student Rights & Responsibilities, which were previously provided to the trustees, and are provided once more as the final document for Board approval.

## **BUDGET AND FINANCE**

Quarterly Financial Report

Dr. Tysha Tolefree, Vice President for Finance and Operations, reported on the 2022-23 third quarter financials:

- The overall results of the Q3 Operating Budget was a net negative variance of (\$1.9M) as compared to FY22 for the same period.
- The total operating revenues for Q3 ending 3/31/23 was \$40.2M as compared to \$39.7M for FY22 during the same period. The slight increase of 1% is in large part due to a positive variance of \$2.2M in state allocations offset by negative

variances.

- The total operating expenses for Q3 ending 3/31/23 was \$31.1M as compared to \$28.7M for the same period in FY22, which is an 8% increase.
- The overall results of the Q3 Non-Operating Accounts was a net of \$1.3M. The total revenues were \$19.1M, offset by expenses of \$17.8M.
- The current FY23 year-end forecast may change significantly, as we prepare to close the first year of financials within the ctcLink system.
