What is a Victim Advocate?

System-based Victim Advocates from the Thurston County Prosecutor's Office respond to the needs of crime victims in an empowering and proactive manner. They strive to inform victims of their rights under the law in order to facilitate informed participation in the criminal justice system and. System-based victim advocates act as a liaison between victims and Deputy Prosecuting Attorneys (DPAs).

Services that can be provided by **system-based victim advocates** consist of:

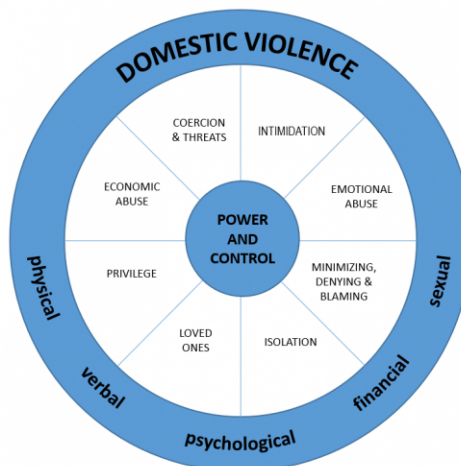
- Safety Planning;
- Informing victims of their rights
- Explaining court process;
- Accompanying victims to hearings and interviews;
- Notifying victims of hearing dates and changes to those hearing dates;
- Familiarizing victims with courtroom prior to trial; and
- Providing a safe space to wait prior to testifying or attending hearings.

Community-based Advocates commonly work for a nonprofit organization. They can provide services before, during, and after a criminal case. Services can also be provided where there is no criminal case. Community-based advocates have a higher level of confidentiality.

What is Domestic Abuse?

Domestic abuse is seen as a pattern of behavior used by an individual against another in order to establish power and control over that individual.



Safety Planning

Practice getting out of your home safely by identifying the best exits:

- Doors (front, back, sliding, garage)
- Windows
- Elevator
- Stairwell

Prepare an emergency bag and keep it in an undisclosed place. Your emergency bag should consist of:

- Clothes
- Cash
- Extra keys
- Extra phone
- Important documents
- Important phone numbers
